COVID19 – How to handle General Meetings better

1. Use of Technology to enable non-physical attendance and voting

- Consider to hold a hybrid AGM
- Check company's constitutional documents and application laws whether hybrid meeting is allowed
- Make sure shareholders are informed in good time with the arrangement
- Share holders can join the meeting without the need to attend physical; reduce the need to have a huge gathering of people in one physical location.
- Reduce the cost in booking a bigger venue to ensure sufficient physical distancing

2. Vote by Proxy


- Encourage more shareholders to vote by proxies (usually by appointing the Chairman) or investors to vote through HKSCC Nominees Limited by giving instructions to their brokers and custodians
- Encourage shareholders or non-registered investors behind CCASS to submit questions ahead of the AGM

3. Management of Physical Meetings

- Check exemption applies for the meeting under the "Prohibition on Group Gathering Regulations"
- Manage the number of physical attendees such as use of multiple meeting rooms linked by telecommunications to reduce headcount at one single venue
- Take all practicable health precautions measures, including mandatory screening of body temperatures, use of face masks, booking a venue with larger space to ensure sufficient physical distancing, no food or souvenir

Our technology operates under a secure dedicated network. All confidential data in both storage and transit are encrypted with industry-standard encryption algorithm.




Hybrid Meeting -Efficient online voting
