How the Awards are Selected

1 Nomination

The Awards are open to public for nominations whose achievements deserve to be honored and have demonstrated the best IR practices for others to learn from.

Online Voting

After confirmation of the nominee's participation, the nominated individuals and companies enter into an online survey. Domestic and international investment community including buy side and sell side analysts, and fund managers are eligible to participate in the online survey and vote on their choices of the Awards. Voters are expected to cast their top 3 choices for each award category.

3 Selection by Judging Panel

Top award finalists in each of the award categories enter into the selection process for the Most Progress in IR and the Overall Best IR Company Awards. Esteemed professionals have been carefully selected as members of the Judging Panel for the HKIRA Investor Relations Awards to ensure a fair and balanced evaluation and selection of award winners.

Mr. Romnesh Lamba

Co-Head of Market Development
Hong Kong Exchanges and Clearing Limited

Mr Lamba is the Co-Head of the Market Development Division at HKEX Group which includes all product development, project management, client and marketing services, mainland affairs, and corporate communications.

Mr Lamba is also a Director of the Stock Exchange of Hong Kong Limited and Hong Kong Futures Exchange Limited, as well as a member of the HKEX Management Committee. Mr Lamba joined HKEX in February 2010 and has held various positions in senior management. In 2012, Mr Lamba and his team were instrumental in leading HKEX's acquisition of the London Metal Exchange. Mr Lamba has also been representing HKEX in regular discussions with the company's institutional shareholders and the investor community.

Mr Lamba has 30 years of experience in the financial services industry. Prior to joining HKEX, Mr Lamba was a Senior Advisor to JP Morgan's Asia Investment Banking and Capital Markets business, with strategic and operating responsibilities from 2008. He has also worked at Merrill Lynch Asia Pacific for eight years as a Managing Director, where he led the firm's regional Energy and Power investment banking group and served as the Chief Operating Officer of the firm's China Origination business. At Merrill Lynch, Mr Lamba led several landmark listings of Mainland enterprises in Hong Kong. Prior to moving to Hong Kong in 1994, Mr Lamba worked in the financial services industry in the US for nine years. Mr Lamba holds Master of Business Administration and Bachelor of Science in Economics degrees from The Wharton School of the University of Pennsylvania in the US.

Prior to joining CFA Institute, he was a senior investment manager in a renewable-energy multinational corporation in Singapore. His portfolio revolved around carrying out intensive due diligence exercises in North America, Europe, and Asia Pacific.

Mr. Lok also spent six years as an equity research analyst; initially with a sell-side research house based in Singapore and subsequently with a buy-side boutique house based in China. As a spokesperson for both companies, he appeared regularly on various financial media such as CNBC, Financial Times, The Edge and The Straits Times to discuss issues related to behavioral finance and macroeconomics. He was also featured regularly as one of the regular guest commentator on Mediacorp's "Good Morning Singapore" – a leading Mandarin-language financial TV program in Singapore.

Mr. Lok has extensive teaching experience in the areas of asset valuation and corporate finance. Concurrently, he serves as an adjunct lecturer at the Nanyang Technological University of Singapore.

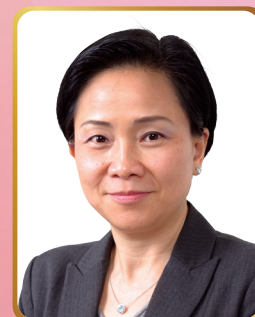
Ms. Kitty Fung

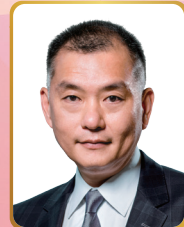

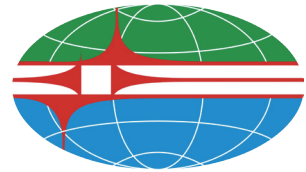

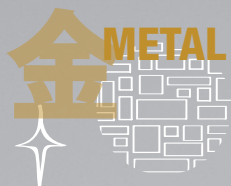
