About the Awards

As a non-profit organisation, Hong Kong Investor Relations Association (“HKIRA”) is committed to promoting excellence in investor relations (“IR”) practices and advocating the setting of international standards in IR for the companies listed on the Hong Kong Stock Exchange.

To achieve this goal, HKIRA has launched the Investor Relations Awards since 2015. The HKIRA 5th IR Awards continues to recognize and honour outstanding IR professionals, and set the industry benchmark for high standard of excellence in investor relations by individuals and listed companies in Hong Kong.

How are the Awards selected

1 Nomination

The Awards are open to public for nominations whose achievements deserve to be honored and have demonstrated the best IR practices for others to learn from.

2 Online Voting

After confirmation of the nominee’s participation, the nominated individuals and companies enter into an online survey. Domestic and international investment community including buy side and sell side analysts, and fund managers are eligible to participate in the online survey and vote on their choices of the Awards. Voters are expected to cast their top 3 choices for each award category.

3 Selection By Judging Panel

Top award finalists in each of the award categories enter into the selection process for the Most Progress in IR and the Overall Best IR Company Awards. Esteemed professionals have been carefully selected as members of the Judging Panel for the HKIRA Investor Relations Awards to ensure a fair and balanced evaluation and selection of award winners.
