About Investor Relations Awards

(IR Award)

The HKIRA Investor Relations Awards (the “IR Awards”) is an annual campaign that aims to encourage, recognize and reward the excellence in investor relations practices by individuals and companies listed in Hong Kong Stock Exchange. Since the launch in 2015, each year the Awards seeks out and highlights the incredible achievements of individuals and companies with high standards in investor relations through their role modeling to the investment community.

The Awards ceremony, consisting of a conference in the morning and presentation in the afternoon, is a spectacular gathering of IR specialists and industry professionals that applauds and publicizes the year’s achievements in investor relations.

How are the Awards selected

1

NOMINATION

The Awards is open to public for nominations whose achievements deserve to be honoured and have demonstrated the best IR practices for others to learn from.

2

ONLINE VOTING

After confirmation of the nominee’s participation, the nominated individuals and companies enter into an online survey. Domestic and international investment community including buy side and sell side analysts, and fund managers are eligible to participate in the online survey and vote on their choices of the Awards. Voters are expected to cast their top 3 choices for each award category.

3

SELECTION BY JUDGING PANEL

Top award finalists in each of the award categories will enter into the selection process for the Most Progress in IR and the Overall Best IR Company Awards, while the top finalists of the Best ESG (E), Best ESG (S) and Best ESG (G) Awards will enter into the selection process for the Grand ESG Award. Members of the Judging Panel for the HKIRA Investor Relations Awards have been carefully selected among esteemed professionals to ensure a fair and balanced evaluation and selection of award winners.

His role encompassed overseeing the analysis and evaluation of opportunities for strategic equity investment in Asia, including China, Hong Kong and Taiwan. During his tenure, Mr. Tsang managed \$1 billion in private equity funds, with approximately 50 portfolio companies. He was involved in the management of a \$3 billion fund, which was the largest Central Eastern European listed closed-end fund at the time of IPO in London.

From July 2007 to June 2008, Mr. Tsang joined Lehman Brothers, where he managed private equity projects in Hong Kong, China, Taiwan and the United States. At Lehman Brothers, Mr. Tsang managed \$500 million proprietary funds. Since March 2021, Mr. Tsang has served as the CEO and Chairman of Model Performance Acquisition Corp. Mr. Tsang has served as a director of the CFA Society of Hong Kong from 2013 to 2021. Mr. Tsang obtained his MBA from The University of Chicago Booth School of Business in 2017, the second Bachelor degree of Law from Tsinghua University in 2005 and a Bachelor degree of Engineering from the Chinese University of Hong Kong in 1998. He is a charterholder of Chartered Financial Analyst from the CFA Institute.

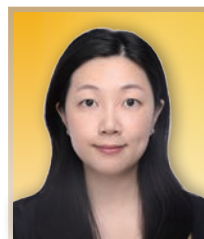

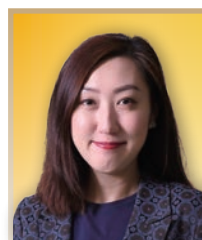

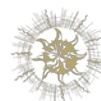
