About Investor Relations Awards (IR Awards)

The HKIRA Investor Relations Awards (the "IR Awards") is an annual campaign that aims to encourage, recognize and reward the excellence in investor relations practices by individuals and companies listed in Hong Kong Stock Exchange. Since the launch in 2015, each year the IR Awards seeks out and highlights the incredible achievements of individuals and companies with high standards in investor relations through their role modeling to the investment community.

The Awards ceremony, consisting of a conference in the morning and award presentation in the afternoon, is a spectacular gathering of IR specialists and industry professionals that applauds and publicizes the year's achievements in investor relations.

How are the Awards selected

① NOMINATION

The Awards is open to public for nominations whose achievements deserve to be honored and have demonstrated the best IR practices for others to learn from.

② ONLINE VOTING

After confirmation of the nominee's participation, the nominated individuals and companies enter into an online survey. Domestic and international investment community including buy side and sell side analysts, and fund managers are eligible to participate in the online survey and vote on their choices of the Awards. Voters are expected to cast their top 3 choices for each award category.

③ SELECTION BY JUDGING PANEL

Top award finalists in each of the award categories will enter into the selection process for the Most Progress in IR and the Overall Best IR Company Awards, while the top finalists of the Best ESG (E), Best ESG (S) and Best ESG (G) Awards will enter into the selection process for the Grand ESG Awards. Members of the Judging Panel for the HKIRA Investor Relations Awards have been carefully selected among esteemed professionals to ensure a fair and balanced evaluation and selection of award winners.

Purpose

The IR Pledge Program is designed to recognize the excellence in investor relations practices by companies listed in Hong Kong Stock Exchange and provides an invaluable opportunity to:

- promote the importance of investor relations profession, and
- raise awareness and understanding of the investor relations community

How does the program work?

The IR Pledge Program commences in the second half of 2021. Interested listed companies can join by application or by invitations from HKIRA.

Who can join the Program?

- A corporate member of HKIRA at the time of application
- The company demonstrated its commitment to best investor relations practice by fulfilling the following criterion which are not exhaustive:
 - (i) has at least one full-time dedicated IR staff
 - (ii) The company has posted its shareholder communication policy on its website
 - (iii) C-levels or senior management attend investor meetings regularly
 - (iv) maintaining good relationships with different stakeholders through various channels

What benefits does the program offer?

All the companies that are currently under the IR Pledge will be listed on the HKIRA's website. HKIRA will grant authorization to use the HKIRA IR Pledge logo on company/IR's website, business cards, letterheads, email footers, signatures, financial reports, other published materials etc.

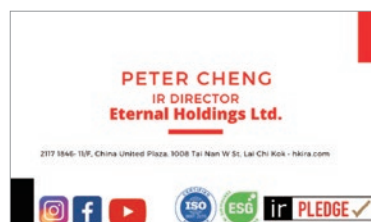
