



With the tremendous contribution and support from the IR Panel, the Association has released its first publication "Investor Relations Best Practice Guide" in last December... We believe it is the first guide written for the local IR industry. Positive responses were received since the Guide launched.

Dear Fellows & Members,

Year 2018 marks our 10th anniversary of establishment. It is my joy and honour to witness HKIRA, over the time, unwaveringly pursued its mission to promote IR best practice in Hong Kong, and cultivate the growth and development of the local IR industry.

The Hong Kong and global finance markets have been in flux for the past year. The implementation of MiFID II brought inevitable effect to IR activities, with impacts, especially to small- and mid-caps, gradually emerge over time. The HKEX's new listing regime with Weighted Voting Rights (WVR) structures finally started, despite aroused much discussion. Shareholder activism is surging in Hong Kong. Cryptocurrencies springing up along new challenges. We see in real cases that effective and continuing communication between corporates and investors is exceptionally crucial. The importance of investor relations is getting more prominent when listed companies encounter the impact of changes in regulation, market structure and technology.

I am delighted to report that 2017/18 was another strong year for HKIRA. We have delivered a dynamic events calendar of 38 events to serve our 750 members, forthputting partnership with various professional bodies, corporates, and industry service providers to bring reputable speakers from local and worldwide for a broader exploration in best practices of investor relations. The morning Conference was programed to address the important trends in IR. HKIRA is proud to see the IR Awards has established with its reputation.



HKIRA 4TH INVESTOR RELATIONS AWARDS

The HKIRA Investor Relations Awards ("IR Awards") has come to the fourth consecutive year to recognize and honour excellence in investor relations by those listed companies and IR professionals who have demonstrated best practice that make up the dynamic IR and finance industries in Hong Kong.

The 4th IR Awards announced the opening of nomination with a media briefing on 29 January 2018. The 5-week nomination period ended on 3 March 2018, and candidates whom have accepted the nomination entered into a 5-week period of online voting from 16 March to 14 April 2018.

To honour excellence across a broader range of IR aspects, this year, we have expanded the Best IR Presentation Collaterals across three categories, "Best Digital IR," "Best Investor Presentation Material" and "Best Annual Report" to recognize expertise of candidate companies in these specific areas.

Thanks to the widespread support from the investment community, the keen enthusiasm for the 4th IR Awards can be seen from the entry of 184 listed companies, including 54 large cap, 64 mid cap, 65 small cap, and 6 IPOs (all are also nominated for large cap, mid cap and small cap award categories respectively). Award winners were selected based on online voting from both the buy-side and sell-side investors. The IR Awards have received vast support from the investment community with over 600 voters. This year, a total of 48 listed companies were awarded in different categories.

The IR Awards carried on the aim to ensure a fair and balanced evaluation. Members of the Judging Panel were carefully selected ranging from various perspectives including investors, compliance, financial reporting, academia, and professional associations. These esteemed professionals served with their dedication and effort in making the 4th IR Awards a sound and reputable recognition for the local IR professionals. Despite number of entrees and award categories increased, the number of winning companies is less than the previous year. This demonstrated the stringent criterion of the judging panel as the gatekeeper. All winners well deserved the glory, and amongst all award categories, winning the honour of the "Overall Best IR Company" is the most prestigious.

4th IR Awards Conference and Presentation Luncheon

Together with the Judging Panel members, HKIRA proudly announced and presented the Awards during the 4th IR Awards Conference and Presentation Luncheon on 21 May 2018 at the Conrad Hong Kong. Over 300 guests from listed companies, the IR industry and investment community attended this premier gathering to share the latest insights and applaud for the best listed companies in Hong Kong.

HKIRA had the honour to have Mr. Ashley Alder, JP, Chief Executive Officer, Securities and Futures Commission (SFC), Chairman of the Board, International Organization of Securities Commissions (IOSCO), as the Guest-of-Honour of the Awards Presentation Luncheon, whom delivered the keynote speech and presented the "Overall Best IR Company" Awards. The event was full of cheers and applause for the winners of the Awards, as the CEO, CFO and IR teams of the listed companies received their trophies on stage.

Conference in the morning comprised of professionals from different aspects to share on the hottest and most relevant issues in the IR community. Topics included relative corporate valuation effects found in Awards voting by investors, discussion of how investors read sell-side reports, bringing IR onto the Board's agenda, and the impact of big data and Al on investor relations. The number of attendees is keep on increasing.





EVENTS

HKIRA had another successful year in organizing events for our members. During 2017/18, HKIRA had arranged 38 events, including 16 hosted by HKIRA and 22 through partnering other organizations supported by us. These events were held in form of conferences, seminars, luncheons, and round table discussions covering a variety of topics from IR strategies to shareholders activism. A total of over 1,700 IR practitioners, corporates and industry professionals in Hong Kong and PRC attended these events (2016/17: over 1,500 event participants), an overwhelming increased of number of participants by 13.3% as compared to last year. Our flagship Annual IR Award and IR Symposium continued to attract large crowd of attendants, and attention from media and investors.

During the year, one of the major market developments which affect investor relations was the implementation of MiFID II. HKIRA collaborated with Bloomberg to organize a lunch seminar with seasoned IR officers, investors, and service providers in panel discussions to explore this matter and to help IR practitioners fully understand and mitigate the negative impact.

It is no exaggeration to say that shareholder activism is an inevitable trend happening in Hong Kong. To help our members be prepared to confront the challenges positively and tactically, HKIRA organized a full-day conference jointly with ONC Lawyers. International and local speakers shared views and experience on shareholder engagement and activism from various perspectives, including investors, asset managers, listed companies, regulators, academia, as well as activists. The conference was well attended with many lively discussions, which met our aim to provoke positive conversation.

As an ongoing effort to help enhancing visibility of HKIRA corporate members, HKIRA introduced a new initiative to invite our corporate members, by sector, to present their investment stories to HKSFA members who are mostly fund managers and sell-side analysts. Three property developers who are HKIRA members were invited, and the event was well attended.

For the upcoming year, HKIRA will continue its commitments on promoting the IR industry and strives to help our members to navigate in the ever-changing macro and regulatory environments. The Event Sub-Committee will focus on organizing new kinds of events with unconventional topics and innovative delivery format. In addition to continue to invite experience IR practitioners and seasoned investors to share their experience and insights, the Event Sub-Committee is in the progress to developing activities to engage HKIRA members to participate in hand-on workshop on using tools, services and technologies which could enhance both the effectiveness and efficiency of the IR functions. We look forward to seeing all of you in these new initiatives in 2018/2019.







Membership Sub-Committee aims to establish HKIRA as the most influential platform by connecting IR professionals across various industries to share, learn and further advance in the IR industry.

During 2017/18, the total number of our members grew by approximately 16% to almost 750 members. The continuous and steadily growing curve in the membership demonstrated the expansion of the IR family, and the increasing awareness from listed companies, investment community and regulators.


Growing Number of HKIRA Members




Our membership profile remains extremely diversified, covering a wide spectrum of professionals from IR to IR-related roles such as finance, accounting, company secretary and business investment. 70% of our members are executives from listed companies. These members represent approximately 367 listed companies with over HK\$17 trillion market capitalization in aggregate (2016/17: approximately HK\$17 trillion); over 50% of the Hang Seng Index Constituent Stock companies are currently members of HKIRA. Among the listed company members, over 50% work at listed companies with market capitalization of over HK\$10 billion. The industry sectors that our members represent continue to be diversified such as conglomerate, finance, industrial, real estate, retail, TMT and more.

Member Survey 2018

We have conducted a Member Survey in June 2018 to solicit members' feedback on HKIRA's services and how HKIRA can serve members better. EDUCATION

HKIRA believes continuous learning support our members to achieve IR best practice and professional development. HKIRA continues offering programs with different academia and professional bodies to cater the demand of IR professionals.

We continue to collaborate with the School of Professional and Continuing Education of the University of Hong Kong ("HKU SPACE") in providing training program for the "Executive Certificate in Investor Relations" ("ECIR"), which has been launched since year 2013. This taught-training program is tailor-made to equip local professionals with formal IR training. The program provides students with the key concepts and practices in investor relations, and covers a range of practical tools, application and research to provide a solid foundation for IR. Topics include capital markets, corporate governance, ethics, regulations, corporate finance, communications and investor relations practices. Seasoned professionals in the industry are invited to share their expertise and practical experience with students. The program also benefits the students through workplace sharing and networking with fellow students. As of to date, nearly 200 students have attended the HKU SPACE ECIR Program.

We have also maintained partnership with the UK Investor Relations Society for the 6th year since 2012 to provide the Certificate in Investor Relations ("CIR") Program. The CIR program is an internationally-recognized qualification in IR for those who are in pursuit of their IR profession. The program is regarded as an essential prerequisite and a valuable benchmark. The qualification ensures an appropriate level of knowledge in regulatory compliance, financial and capital markets, which will enhance the professional competence, career development and industry recognition for the candidates. As of to date, 102 candidates have successfully passed the examination in Hong Kong and have received the Certificate in Investor Relations through HKIRA.

We are committed in supporting IR executives at their various career stages to excel through formal IR education, training programs workshops and seminars that meet their ongoing professional development needs. We will carry on to pursue cooperation opportunities with professional and academic institutions for the betterment of our members and all those who strive to advance in the IR profession.

MARKETING AND PROMOTION

In 2017/2018, HKIRA continued to devote great efforts to promotion and marketing. During the year, we had increased our publicity by collaborating with well-recognized entities such as HKEX, Bloomberg, ONC Lawyers and etc. on branding and promotion initiatives. The interview featured their daily IR work, sharing of how they have become an IRO, and the career prospect of this profession. The program would help initiate interest and concern to the occupation of IR, and hence attract new blood.

HKIRA is also in the forefront of going digital to facilitate our promotion and marketing. All of our events and activities in 2017/2018 were made available on popular social media platforms, including Facebook, LinkedIn, and WeChat, in addition to publishing updates on our website and email circulation of bi-monthly e-Newsletters. These online media allowed HKIRA to closely connect with financial community and IR practitioners of other countries. Our official website is available in responsive web design to provide a user-friendly on-the-go browsing experience. Registration and payment for our events could be made online in a highly efficient manner.
