# PAIB forum: Disclosing key areas of corporate governance (3) – Shareholder communications

## About the topic

This is the third professional accountants in business forum in the series on corporate governance and disclosure. At this event, a prominent panel of speakers will discuss key disclosure issues relating to listed companies' communication with their shareholders, and how to provide meaningful disclosure in annual reports. The discussion will be based around the new corporate governance disclosure guide published by the Institute. The objective of the guide is to help listed companies provide meaningful disclosure, by understanding the key principles and provisions in the Corporate Governance Code under the listing rules, as well as the expectations of intended report users in terms of disclosure of information.

This event will start with a brief introduction to the relevant section of the guide, and an overview of the applicable areas of the Corporate Governance Code, which address shareholder communications generally, including private and institutional shareholders. Following this, panel members will share their insights from the perspectives of management, investor relations professionals, and investors (buy side). The panel will look at effective practices and disclosures in relation to shareholder communications, covering institutional investors in particular, and how to encourage participation by shareholders. Members can share their views and experiences on the area of shareholder communications in the discussion session.
