An Exceptional Who's Who List of IR Professionals and Hong Kong Listed Companies are Honored

Hong Kong (May 7, 2015) – Hong Kong Investor Relations Association (HKIRA) today announced the winners of its inaugural HKIRA 1st Investor Relations Awards (the "Awards"). Guests from listed companies and the IR profession were present at today's IR Awards Conference and the Awards Presentation Ceremony to celebrate the winners' IR excellence and their dedication to IR best practice. HKIRA was honored to have Mr. Romnesh Lamba, Co-Head of Global Markets, Hong Kong Exchanges and Clearing Limited as the keynote speaker for the Award Presentation Ceremony.
