Hong Kong Investor Relations Association (“HKIRA”) is committed to promoting excellence in investor relations (“IR”) practices and advocating the setting of international standards in IR for the companies listed on the Hong Kong Stock Exchange.

To achieve this goal, HKIRA launched the inaugural HKIRA 1st Investor Relations Awards (the “Awards”) in early 2015. The Awards aim at commending IR best practices and focus on recognizing Hong Kong-listed companies and the local IR professionals their excellence and achievements in investor relations.

Nomination

The Awards is open to public for nominations whose achievements deserve to be honored and have demonstrated the best IR practices for others to learn from.

Online Voting

After confirmation of the nominee's participation, the nominated individuals and companies will enter into the online survey. Domestic and international buy-side and sell-side analysts, and fund managers will participate in the online survey and vote on their choices of the Awards. Voters are expected to cast their top 3 choices for each award category. Nominees with the highest votes (weighted) will be the award winners.

Selection by the Judging Panel

Top award winners in each of the award category will enter into the final selection process for the Overall Best IR Awards. Esteemed professionals have been carefully selected as members of the Judging Panel for the HKIRA Investor Relations Awards to ensure a fair and balanced evaluation, selection of the Overall Best IR Awards and the entire results.

Mr. Lamba is also the Chief Executive of the Stock Exchange of Hong Kong Limited and Hong Kong Futures Exchange Limited, as well as a member of the HKEx Management Committee and a Board Director of the London Metal Exchange and LME Clear.

Mr. Lamba has 28 years of experience in the financial services industry. Before joining HKEX, Mr. Lamba held senior positions at JP Morgan's and Merrill Lynch's Asian Investment Banking groups. He worked in the US for nine years before moving to Hong Kong in 1994. Mr. Lamba holds Master of Business Administration and Bachelor of Science in Economics degrees from The Wharton School of the University of Pennsylvania in the US.
